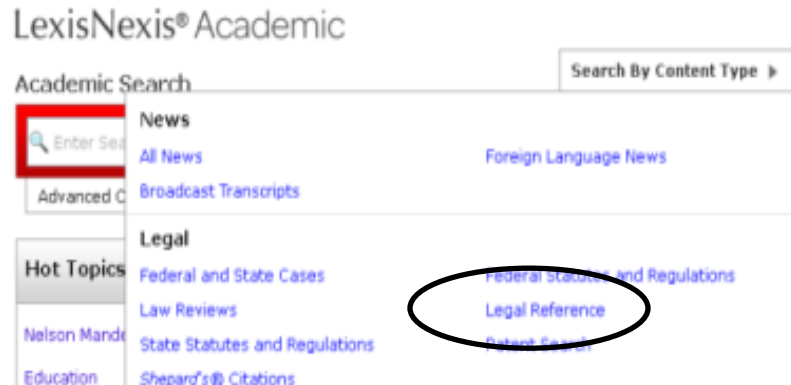
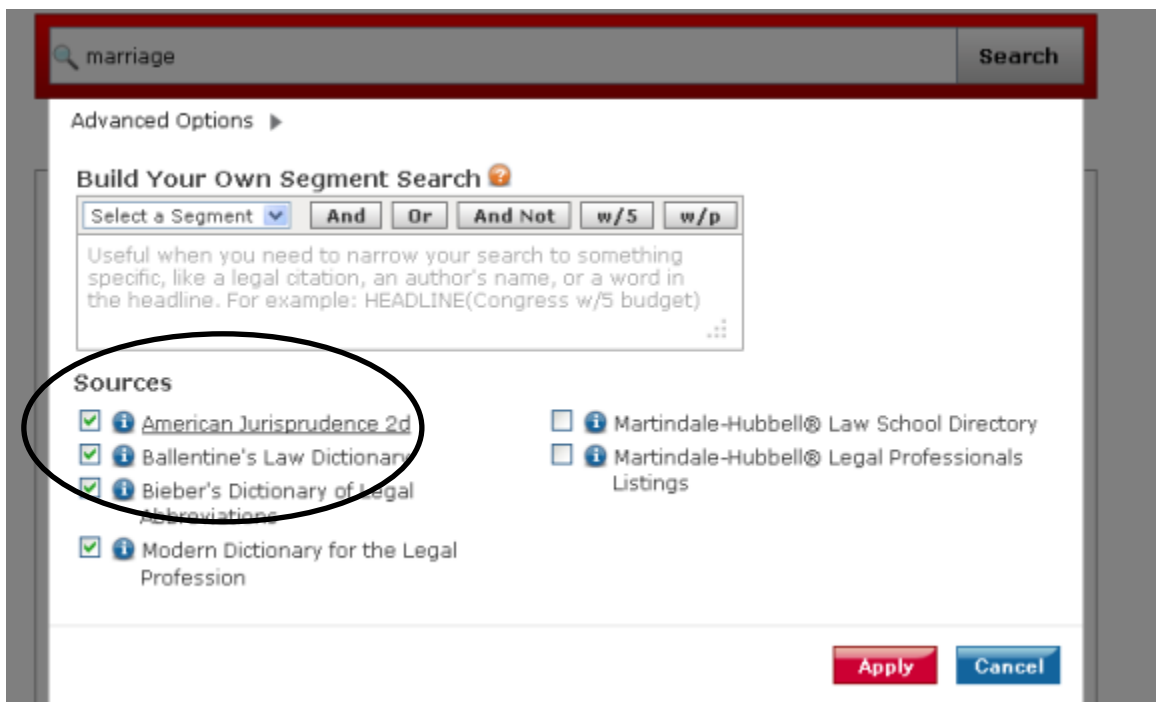


## How do I find legal reference sources?

**Step One:** Visit the Lexis-Nexis Academic homepage. Select “Search by Content Type” and then “Legal Reference” in the Legal category.



**Step Two:** At the next screen, links to landmark cases will be available. Insert a keyword (subject) in the red search box. Now select “Advanced options.” Select a source of interest among the law dictionaries, directories, and *American Jurisprudence* (2<sup>nd</sup> ed.). Select the “i” preceding any source name for further information. Now select “Apply” and then “Search” from the red search box.



**Step Three:** Now select a title from the search results to view the corresponding entry or article. Printing, saving, email, and exporting options appear in the tools' roster with each article.
